CRITERIA:

Open to an International student, 17 years of age or older, with an active Scotiabank GIC Account - must provide proof with application. Students must meet minimum GPA or equivalent as determined by Northwestern Polytechnic. Enrolled as a first-term student starting either the September 2023 or the January 2024 term at NWP as a full-time student for two consecutive semesters.

Requirements:

International / Visa student
Active GIC account – Attach to application
Students must be attending studies on an NWP Campus
Attending 9 credits or greater for two consecutive semesters starting in September 2023 or January 2024
Students must be 17 years of age or older
Students must meet a minimum GPA of 1.7 in their first semester or equivalent as determined by NWP
