#### **REQUIRED TEXT/RESOURCE MATERIALS:**

#### **CALENDAR DESCRIPTION:**

Identification, use, care and maintenance of surgical instruments, equipment and supplies is covered in detail. Students learn to prepare facilities, patients and equipment for surgical procedures with strict adherence to principles of sanitation and sterilization. Students will participate in surgical procedures as a surgical assistant and will learn to pass instruments, care for exposed tissue and provide suction or cautery. Students become responsible for post operative clean up of the patient, equipment and facilities and follow up with patient monitoring and surgical records.

## **OBJECTIVES:**

**Module 1: Facility and Patient Preparation Upon** successful completion of this Module, you will be able to describe and demonstrate the appropriate use of surgical instruments and supplies; prepare facilities, equipment and the patient for surgery.

- 1. Describe the principles of sterilization, identifying solutions and preparations that are used.
- 2. Describe, operate and maintain autoclaves.
- 3. Identify, use and maintain surgical instruments.

- 4. Identify surgical garments and draping materials, and demonstrate their appropriate uses.
- 5. Prepare surgical suite for surgery.
- 6. Administer local anesthetics (cornual, epidural, paravertebral, line block) as required.
- 7. Prepare surgical site using aseptic technique.

Module 2: Surgical Assistant Upon successful completion of this Module, you will be able to perform as a surgical assistant.

- 1. Prepare and perform aseptic surgical scrub.
- 2. Describe and demonstrate appropriate operating room conduct.
- 3. Maintain operating room asepsis.
- 4. Describe and demonstrate draping of a patient.
- 5. Describe and demonstrate how to properly pass instruments and supplies.
- 6. Assist with care of exposed tissues and /or organs.
- 7. Describe the use of suction, cauterizing and fiber optic equipment.

Module 3: Post Surgical Duties Upon successful completion of this Module, you will be able to perform post surgical duties.

- 1. Describe and apply effective OR clean up.
- 2. Describe and apply effective preparation room clean up.

#### Module 4: Suturing

Upon successful completion of this Learning Outcome Guide, you will be able to perform common sutures and knots used in veterinary practice. (LAB: SUTURING LAB)

- 1. Differentiate between a square knot and surgeons knot.
- 2. Demonstrate and explain the application of a surgeons knot.
- 3. Apply and remove simple interrupted, cruciate, simple continuous, and Ford interlocking sutures.
- 4. Identify common types and sizes of suture material.
- 5. Identify common suture patterns and knot tying.
